



## UF Fees and Rush Chart

H-1B, TN, E-3 and O-1 requests are initiated online at the UF/Fragomen IHP, <https://immigration.fragomen.net/login>. By submitting the case as early as possible, it increases the chances that the request can be processed and approved timely, reducing the likelihood of needing Rush/Expedited Service.

#### O-1

Days Before Start	Rush Fee

This is counted by when the International Employee provides their information and documentation. There can be additional Rush fees incurred depending on how close it is to the start date when Fragomen receives the necessary information.
